



## Fourth Annual *Be a Blessing* Campaign - 2022 AZ Tax Credits to Benefit Christian Care Health Center

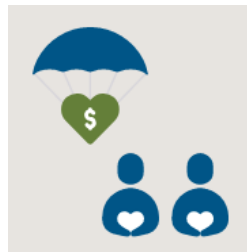
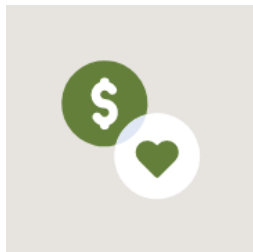
